

Indiana Choice Scholarship Program (Vouchers) and Tax Credit Scholarships (SGO)
Income Limits by Household Size
2022-2023 School Year

The State of Indiana offers School Choice Vouchers and the SGO Scholarship program to help eligible Hoosier families choose and afford the most appropriate education for their child(ren). To be eligible for a voucher, families must meet BOTH an income and a track requirement. In addition, Heritage Christian School also offers tuition assistance to eligible families. The information below provides guidance on voucher and tuition assistance program eligibility. To determine if you meet the income eligibility requirement, find your household size in the chart far left column; your household income, as defined below (**), must be equal to or less than the amount shown in the center "Voucher K-12" column. Refer to the "Student Tracks" section below for more information about meeting the track eligibility requirement. ***Household Size -**

The term household means a group of related or nonrelated individuals who are living as one economic unit and who share housing and or significant income and expenses.

****Household Income -** The following types of income must be included for all members of the household:

- Earnings from work (wages, salaries, tips, commissions, overtime pay, bonuses, etc);
- Welfare/Child Support/Alimony;
- Child's Income from full-time or regular part-time job;
- Retirement/Disability Benefits; and
- Other Income (retirement account distributions, rental and interest income, living allowances, etc)

Additional Information:

Vouchers are not available at Heritage Christian School for Pre-School or Prep-K students

Vouchers offset only part of the cost of tuition at Heritage Christian School; families pay the balance after aid/voucher credits

Voucher seats may be limited and are made available through an annual lottery held on or about March 4th

Students must be accepted through the HCS application process and have a verified financial aid application to be eligible for the lottery

Voucher application is made by HCS on behalf of eligible families no later than Sept. 1 or Jan. 15 for the school year
